Expenditures

During this period, a total of \$477,976.74 federal funds from this grant were expended. This includes \$477,189.27 to reimburse county election offices for allowable expenses.

The remaining \$787.47 was spent on travel to provide security training to county elections officials.

In addition, the state spent all \$205,553 or required matching funds through reimbursements to counties.

Interest Accrued

During this period, the State of Utah deposited HAVA 101 funds in a Public Treasurers' Investment Fund account maintained by the Utah State Treasurer. The accrued interest totaled \$87,113.61.
