Describe in detail how you used the funds to address the pandemic and explain how you implemented the approved grant activities.

In response to the COVID-19 pandemic, Indiana was awarded \$8,013,610 in CARES funds. Consistent with the grant's spirit, it was Indiana's goal to address potential coronavirus threats by minimizing direct contact among Hoosier voters and election staff, educating poll workers on sanitation best practices, ensuring polling locations were supplied with the necessary personal protective equipment (PPE), and ensuring counties were reimbursed for unforeseen expenses associated with the Primary and General Election, all while maintaining the highest standard of election security and integrity.

11. Describe the major issues you faced in dealing with the pandemic and how you addressed or resolved those issues.

With several changes to Indiana's routine election procedures and various election modifications highlighted across the country, it was imperative to maintain voter confidence and ensure Hoosiers had pertinent election information. In total, \$2,300,000 of CARES funds were put towards voter outreach. During the Primary Election, Indiana supplemented and repurposed our existing outreach with \$1,300,000 in CARES funds to ensure voters were aware of the changes surrounding the Primary Election, including new protective procedures and amended deadlines. Additionally, postcard mailers were sent to voters encouraging them to volunteer as poll workers. This ensured that each county polling location was adequately staffed. Leading up to the General Election, Indiana supplemented our existing outreach with \$1,000,000 in CARES funds for poll worker recruitment, election announcements, and to ensure voters were aware of the changes surrounding the General Election, including new protective procedures.

We are proud to say that despite the unprecedented circumstances, Indiana conducted both a successful Primary and General Election. With shelter-in-place orders beginning in March and cases of COVID-19 spiking in the spring, Indiana came to a bi-partisan agreement to delay the Primary Election one month and suspend absentee by-mail restrictions, among other voting accommodations. Indiana determined delaying the date of the Primary Election was the safest course of action, while providing Hoosiers the opportunity to vote and maintaining the highest standard of election security. However, this adjustment, along with securing the necessary PPE, presented significant obstacles.

The rapid, widespread development of COVID-19 and the needs of critical health care workers severely limited the availability of PPE through customary distribution channels. Furthermore, there were no individual manufacturers or distributors that could provide all the various types of PPE and quantities. In response, Indiana developed new and alternative supply channels that did not disrupt supply chains for critical health care and essential workers. Given the lack of historical experience and data, determining the appropriate types of PPE and needed quantities presented a unique challenge. Indiana had to procure enough PPE to protect polling places and central count locations, while ensuring the disinfectant solutions were safe to use on current voting equipment. This required Indiana to develop and establish a consensus among voting equipment vendors on a "universal" cleaning and disinfecting solution that could be safely used across the spectrum of voting systems.

After navigating through the obstacles to conduct a successfully Primary Election, Indiana invested the summer and fall preparing for the General Election. In a time of unknowns and anxiety, it was our goal to conduct a routine, traditional General Election and strive to promote a sense of normalcy for Hoosier voters. In doing so, this presented a unique set of obstacles as we navigated through the COVID-19 landscape to carry out a "normal" election in abnormal conditions.

Of the many obstacles we faced, one of the most significant was securing the necessary PPE. In order to carry out a traditional election with 28 days of in-person voting, the amount of PPE required for the General Election was much more significant than that required for the Primary Election. Indiana had to procure enough PPE to protect all polling places and central count locations, while ensuring the disinfectant solutions were safe to use on current voting equipment. The rapid, widespread development of COVID-19 and the needs of critical health care workers severely limited the availability of PPE through customary distribution channels. Furthermore, there were no individual manufacturers or distributors that could provide all the various types of PPE and quantities. In response, Indiana developed new and alternative supply channels that did not disrupt supply chains for critical health care and essential workers. Additionally, Indiana had to calculate the required amounts of PPE counties needed for the General Election and evaluate how much PPE was remaining after the Primary Election. We were forced to refine our original PPE calculations in order to provide initial and supplemental PPE to all counties.

12. Describe in detail what happened during this reporting period and explain how you implemented the approved grant activities.

As of the date of this report and to close out this reporting period, over \$8,002,000 in CARES dollars was been spent during the last calendar year. In total, \$3,021,940 went towards securing PPE for Indiana's 92 counties to use in the Primary and General Elections. With assistance from the Indiana National Guard, PPE was distributed to all counties before in-person early voting began and was stocked at every polling location throughout the state. For the Primary and General Elections combined, Indiana purchased 15,000 gallons of hand sanitizer with 2,700 refillable dispenser bottles, 3,100,000 pairs of disposable gloves, 1,313,000 ear loop facemasks for staff and voters, 4,300 sneeze guards, 25,550 face shields, 150,000 microfiber disinfectant cloths, and 20,000 spray bottles for voting machine sanitation. Additionally, over 50,000 CDC guideline posters and 40,000 social distance markers were distributed to each county in order to keep staff mindful and vigilant.

In an effort to accommodate unexpected expenses incurred in response to COVID-19, CARES funds were made available to Indiana counties through two reimbursement grants. The first grant reimbursed counties for costs associated with the Primary Election. These funds were awarded to counties on September 15, 2020. The second grant reimbursed counties for costs associated with the General Election. These funds were awarded to counties on December 16, 2020. County reimbursement data will be included on Indiana's final financial report to the EAC. Additionally, we have already begun working towards our 20% state match requirement and are happy to provide a state match summary upon request.

ensured that each county polling location was adequately staffed.

To promote election and cybersecurity, we reimbursed select counties for cybersecurity system deployment and installation. This ensured that election systems were secure and not threatened despite changes to traditional election procedures, such as no-excuse absentee voting implementation and delaying the Primary Election.

In an effort to accommodate unexpected expenses incurred in response to COVID-19, CARES funds were made available to Indiana counties through two reimbursement grants. The second grant reimbursed counties for costs associated with the General Election. These funds were awarded to counties on December 16, 2020.
