As described in the previous report, the State Election Commission of Puerto Rico as the established programs and budget narrative submitted before, distributes these funds to accomplish the following activities: prevent, prepare for, and respond to coronavirus for the 2020 elections. This report shows almost the complete disbursement from the inception of the grant until January 31, 2021. The final disbursements will be reflected in the next report.

HAVA CARES funds were used to attend the massive increase in Absentee Voting solicitations, to ensure a safe environment for voter and electoral staff and comply with the educational campaign for voters on how to exercise their right to vote in a safe

way, protecting them for COVID-19 contagion. Also, the funds helped the State Election Commission to guarantee a safe place all the time in the workplaces and in the polling places. CARES funds were used to continuously cleanse and disinfect shared areas, acquiring thermometers for the monitoring of all voters and polling officials, purchases for the acquisitions of masks, hand sanitizer, gloves, face shields, and other prevention material for the electorate and polling officials.

In the categories and budget program established we have expended the following:

#### 11. Describe the major issues you faced in dealing with the pandemic in the election cycle.

Besides the recent challenges that Puerto Rico has faced, taking into consideration the polling centers' relocation because of the current southern earthquakes, the main ones identified were the short time to perform the electoral activities in a pandemic. Considering the lock down, one of the massive challenges faced was finding suppliers to provide us with the equipment and materials to carry out the activities for these electoral events, ensuring the security measures to prevent COVID\_19. As a result, it is the first time that The Puerto Rico State Election Commission was required to perform the equivalent of two general elections, considering the massive increase in absentee voting solicitations. As previously reported, a judicial determination extended the date of applications for absentee voting for people and over 60-year-old, making the electoral process even harder. As a reference, in 2016, the total absentee vote was 23,189, while for the 2020 election it was 227,769, an increase of almost nine times than in past elections.

During this reporting period all the activities under the grant were performed. As described and previously reported, the present report will show disbursements of pending obligations made during the General Elections. The disbursement under the different activities are detailed below:

The State Election Commission (CEE) had to ensure state participation allocating some expenditures as additional absentee ballots and cleaning materials and supplies for COVID\_19 prevention under the State Election Funds. As of today, the expenditures made under the state election funds are \$447,696.48. However, CEE requested the Financial Oversight & Management Board of Puerto Rico to authorize state funds to fulfill these purposes, totaling \$776,271. These funds have not been used yet because they were approved in October 15, an allocation intended to pay the temporary additional staff settlement payments (liquidations). As with the activities and budget program submitted under this grant, we have a projection of expenditures pending ascending to \$208,270 to implement remote working equipment that couldn't be allocated under the grant because of the limitation of available suppliers that could provide the amount of equipment request.

Other issues encountered by the Absentee Voting Projects Manager faces to carry out the increment of the absentee voting request were as follows:

•Material shortages or late delivery

•Lack of more phone lines for each district

•Lack of equipment and technology such as computers, fax, scanner, and printers to be able to meet the volume of requests by email

Internet band expansion (need for faster connection)

•Materials for printers (inks) for excess uncovered applications

•Systematic training process, which would enable new staff to be trained efficiently, quickly, virtually and individually

•More aggressive disclosure of prevention protocols COVID\_19 in mass media for voters

•Need for a more expansive place

•Need to establish two emails to address absentee and advance voting requests. The only email set from the source was used in these choices, delaying the process by debugging to identify each submission.

In short, project managers presented the current need to amend the manual processes that mostly require physical effort and replace it with an automated system that streamlines the voting process from application to the counting of the votes. It should be noted that the electoral knowledge to carry out these tasks requires a degree of specialty that could be difficult for some voters and polling officials. To this effect, project managers presented an interest in better pay for these tasks.

Also, despite all the factors against (time and restrictions on acquiring equipment), we recognize that limitations such as the grant's usefulness period about the COVID\_19 conditions have limited us to respond more effectively. Indeed, under normal circumstances, we would have acquired tools and equipment for a more significant impact and operation that improved the electoral process and its administration. We understand that the extension of the expense period and the grants permissibility could be beneficial to acquire tools that, in scenarios like this, help us respond more efficiently.

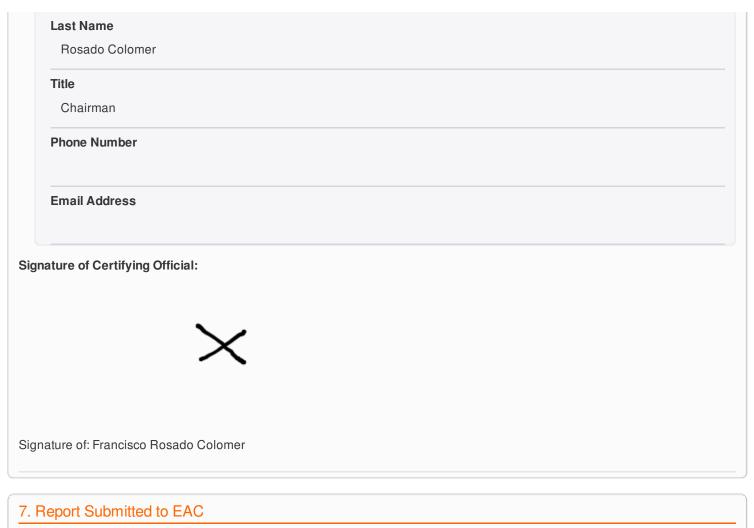
