The federal Coronavirus Aid, Relief, and Economic Security Act (CARES Act), enacted March 27, 2020, included \$400 million in new Help America Vote Act (HAVA) funds, made available to states to prevent, prepare for, and respond to the coronavirus for the 2020 Federal election cycle. This supplemental appropriation funding provided New York State with additional resources to protect the 2020 elections from the effects of the novel coronavirus. New York State provided the required 20% match.

New York State was allocated \$20,463,651 from the federal government and New York State's 20% match was \$4,092,730 – making a total of \$24,556,381 available for use by county boards of elections to implement measures necessary for responsible, safe, and fair elections during the COVID-19 pandemic.

State and local election officials were concerned about the COVID-19 pandemic and its impact on the Presidential Primary, the June 23, 2020 primaries and the November General Election. As such, the State Board of Elections established the NYS HAVA CARES ACT grant program to reimburse county boards of elections for eligible expenses relative to implementing measures necessary for responsible, safe and fair elections during the COVID-19 pandemic. This includes but is not limited to, those costs necessary to protect the health and safety of poll workers, voters and staff, secure physical locations, and address unexpected expenses due to COVID-19 pandemic during a federal election. To be allowable under this grant, costs must be necessary, reasonable and allocable to the grant. Expenditures related to the protection of the health and safety of poll workers, staff, and voters during the federal elections as well as those resulting from unanticipated increased demand for vote costs (e.g. printing ballots, envelopes, postage, processing, receiving, storage, etc.), and equipment.

Due to the Coronavirus, a number of Executive Orders were issued to ensure all registered voters were able to vote safely. Specifically, executive orders were issued, and State laws were enacted to:

- Modify absentee ballot application requirements;
- Require all registered voters to be mailed an absentee ballot application ahead of the June primary election;
- Require pre-paid return envelopes to all registered voters who applied for a primary absentee ballot;
- Require the State to redesign all absentee envelopes in a uniform manner for the general election;
- Require extensive cure provisions to correct absentee ballot deficiencies,
- Require all County Boards of Elections to mail all registered voters a postcard detailing the three options to vote (by absentee, during early voting, or on election day) and where they can vote; and

• Require County Boards of Elections to publish on their website absentee ballot drop box information for the return of absentee ballots to board of elections offices, early voting poll sites or election day poll sites.

County Boards of Elections utilized the HAVA CARES funding to ensure these new election administration procedures designed to ensure staff and voter safety, and to make voters aware of voting opportunities to reduce poll site density.

This 20 day post general election report captures disbursements made to County Boards of Elections through November 13, 2020, totaling \$8,748,836.82. Of the \$8.7 million dollars disbursed, \$8,319,187.69 was disbursed from the federal funds and
