Certification Regarding Lobbying

Certification Regarding Lobbying for Contracts, Grant, Loans and Cooperative Agreements

The undersigned certifies, to the best of his knowledge and belief, that:

- (1) No Federal appropriated funds have been paid or will be paid, by or on behalf of the undersigned, to any person for influencing or attempting to influence an officer or employee of an agency, a Member of Congress, an officer or employee of Congress, or an employee of a Member of Congress in connection with the awarding of any Federal contract, the making of any Federal grant, the making of any Federal loan, the entering into any cooperative agreement, and the extension, continuation, renewal, amendment, or modification of any Federal contract, grant, loan, or cooperative agreement.
- (2) If any funds other than Federal appropriated funds have been paid or will be paid to any person for influencing or attempting to influence an officer or employee of any agency, a Member of Congress, an officer or employee of Congress, or an employee of a Member of Congress in connection with this Federal contract, grant, loan, or cooperative agreement, the undersigned shall complete and submit Standard Form-LLL, "Disc osure of Lobbying Activities," in accordance with its instruction.

Any person who fails to file the required certification shall be subject to a civil penalty o not less than \$10,000 and not more than \$100,000 for each such failure.

Certification Regarding Trafficking in Persons

 - b. Has an employee who is determined by the agency official authorized to terminate the award to have violated an applicable prohibition in paragraph I.A. of this award term through conduct that is
 - i. Associated with performance under this award; or
 - ii. Imputed to you using the standards and due process for imputing conduct of an individual to an organization that are provided in 2 CFR Part 180, "OMB 12 Guidelines to Agencies on Government-wide Debarment and Suspension (Nonprocurement)", as implemented by our agency at 2 CFR Part 2200.
- III. Provisions applicable to any recipient.
 - a. You must inform us immediately of any information you receive from any source alleging a violation of a prohibition in paragraph I A of this award term.
 - b. Our right to terminate unilaterally that is described in paragraph (1) and (2) of this section:
 - Implements section 106(g) of the Tracking Victims Protection Act of 2000 (TVPA), as amended (22 U.S.C. 7104(g), and
 - ii. Is in addition to all other remedies for noncompliance that are available to us under this award.

- c. You must include the requirements of paragraph I A of this award term in any subaward you make to a private entity.
- IV. Definitions. For purposes of this award term:
 - a. "Employee" means either:
 - An individual employed by you or a subrecipient who is engaged in the performance of the project or program under this award; or
 - ii. Another person engaged in the performance of the project or program under this award and not compensated by you including, but not limited to, a volunteer or individual whose service are contributed by a third party as an in-kind contribution toward cost sharing or matching requirements.
 - b. "Forced labor" means labor obtained by any of the following methods: the recruitment, harboring transportation, provision, or obtaining of a person for labor services, through the use of force, fraud, or coercion for the purpose of subjection to involuntary servitude, peonage, debt bondage, or slavery.
 - c. "Private entity";
 - Means any entity other than a State, local government, Indian tribe, or foreign public entity, as those terms are defined in 2 CFR § 175.25.
 - ii. Includes:
 - A nonprofit organization, including any non-profit institutions of high education, hospital, or tribal organization other than one included in the definition of Indian tribe at 2 CFR § 175.25(b).
